Welcome to our 140th anniversary edition

Children 1st was founded 140 years ago. We've reached a milestone, but our anniversary isn't a celebration while so many children are in crisis.

Children 1st has always protected children from abuse and neglect. Just five years ago, the main challenge was parental addiction, sexual exploitation and domestic abuse. Five years later, we add poverty to that list because of a shocking rise in the number of children living in desperate conditions.

One in four of Scotland's children live in poverty. Their families simply don't have money to cover basics. How can we create safety when parents are terrified about paying bills and putting food on the table?

As Scotland's national children's charity, we support families to keep children safe and well. However, as the cost-of-living crisis deepens, and parents are under more pressure because of money worries, it's getting harder to ensure children are protected from harm.

The first thing we must do is make sure children have enough food, warm homes, coats to wear and beds to sleep in. We cannot turn from the catastrophic impact that poverty has on children's health and wellbeing. In fact, in the long-term child poverty affects our whole society.

Our support makes a real difference, and we rely on you to help reach all the children who need us. Thank you for making sure children have food, warm homes and safe families who are not worn down by the neverending grind of not being able to provide. This generation of children are dealing with the aftermath of lockdown which stole years from their childhoods, and they have been thrown into even more desperation because of poverty. Children deserve better. With your help we can offer the support they need.

We've got to protect children. We have to protect childhood.

A crucial milestone for the rights of every child in Scotland



The United Nations Convention on the Rights of the Child (UNCRC) (Incorporation) (Scotland) Bill is now Scottish Law. The Bill was unanimously passed in the Scottish Parliament on 7 December 2023, and after Royal assent was granted in January, most of the Bill provisions will come into force on 16 July 2024.

After more than 30 years of campaigning, Children 1st believes that this law is a crucial milestone in Scotland's journey towards making rights real for every child.

The UNCRC is an international human rights treaty which sets out the rights every child has. Human rights make sure that everyone is safe, healthy, and treated with respect. Children have special rights because they need extra protection, care and support during childhood.

We are committed to supporting Scotland in becoming a rights-respecting nation, and with this Bill we will work tirelessly to ensure this legislation makes a difference to respect and protect children's rights. But most importantly, it should build awareness and prompt a culture change so that we all know and understand these rights and what they mean, and so they become an everyday part of the work that we do.

There's so much more to do to make sure children's rights are fulfilled in the way that the UNCRC envisages. The children and families we work with are facing challenges like never before. Thanks to your support, we shall continue to campaign and protect Scotland's children.




In 1884 there were no laws to protect children. Horrified by the poverty, neglect and abuse that children were suffering across Scotland, a group of like-minded people founded Children 1st to ensure that children were cared for.

Children 1st Parentline was launched in 1999. We recognised that parents and carers urgently needed access to non-judgemental support to share any concerns about a child through a free, Scotland-wide, confidential telephone service.

Children 1st Parentline offers families so much more than a conversation in their hour of need. Ann Jarvis, helpline supervisor, shares "Children 1st Parentline provides a safe space where parents and carers can open up and will be listened to without being judged. Being a parent is tough and sometimes overwhelming. We will take the time to hear what's happening in the caller's life. Together, we look at what can be done to improve their situation such as putting them in touch with our financial wellbeing service who can help them, not only in a crisis but in the long term."

In the last year, nearly 1,800 families were in contact with Children 1st Parentline. More than 1 in 2 callers were concerned about their child's mental wellbeing*. Families also have worries about money, bullying and family relationships.

Whatever the worry, Children 1st Parentline is there to support anyone in Scotland concerned about a child.

The small flat had no electricity and there was no food in the cupboards.

John was at the end of his tether. He needed to buy his daughters Katy, Rhona and Eilidh essentials for their health conditions, and that left no money for the heating or food. In desperation, John called Children 1st Parentline.

Little did John know that his call would become life-changing. The team were able to send emergency fuel and food vouchers straight away and connect John with Lyn from the Children 1st financial wellbeing team to help find a long-term solution.

John really struggled with his dyslexia and health conditions. He was initially sceptical about applying for benefits as previous applications had not been successful. Lyn supported John to apply again for child disability payments for Katy and adult disability payments for himself.

Life was busy for John looking after his girls, taking them to medical appointments whilst being mindful of his own health issues. Lyn set small tasks and reminders to keep John on track, letting him know that she was there when he was ready for the next step. She also gave

John the space to take breaks from the process when he got overwhelmed.

It took nine months to complete the process and thankfully the applications were successful. The trust and relationship that Lyn had built with John and the girls ensured that the process could keep going. If John didn't attend meetings or get back to Lyn straight away, she knew there would be a reason. Whole family support means that we get to

know a family to give them the support they need in the way that they need it.

Family Group Decision Making - giving children and families a voice



Children 1st has pioneeredthe use of Family Group Decision Making (FGDM) in Scotland since 1998.

FGDM recognises that whenever it is safe and possible, children are best looked after within their own families. It is an effective approach to keeping children out of statutory care and is now delivered in over 30 countries worldwide.

Sara Ali, Children 1st national family group decision making development lead shares that "Children 1st co-ordinators organise family group meetings for everyone to come together to discuss a concern or problem involving children or young people in the family. This can range from help for a family early on when they are beginning

to have difficulties, right up to when families are involved with social work and child protection services and are making big decisions about how to keep a child safe or where a child should live."

In Family Group Decision Making, the child and the family involved define who their family is. It might include adoptive parents, foster parents, grandparents, family friends, teachers or other significant people in the child's life.

Family support for Craig

Craig was 15 years old. His foster care placement broke down and he moved in with his gran and his dad on a temporary basis to avoid becoming homeless. Craig's gran is his dad's full-time carer and money is scarce. Craig had no bedroom or private space of his own. After six months, Craig had built a great relationship with his family. However, living in the small flat wasn't a permanent solution.

With support from Claire and Shara at Children 1st, Craig and his family came together to discuss how to best support him using the Family Group Decision Making (FGDM) process. It can help a child's wider family to come together to agree a family plan to support their child before a life-changing decision is made about their future.

This process gave Craig, for the first time in his life, the opportunity to write about what he needed and wanted. He shared that he wanted to continue to build a relationship with his gran and dad, but now aged 16, after being in foster care, he wanted to live on his own.

Craig's family were brought together to speak about how

best to support him and they recognised the additional support that the family needed. Craig would need financial assistance, clothes, employment support and storage for his belongings and his gran should have more support and financial assistance as a kinship carer.

All this information was added to the FGDM plan, which was then shared with Craig's social worker.

Craig continues to stay with his gran and dad until a space in a young person's supported housing unit becomes free. He is getting financial, employment and career development guidance and spending time with his wider family members.

Kinship carers are relatives or family friends who take care of a child who is unable to live with their parents.

FGDM enables families to focus on the future and come up with a solution that holds children like Craig at the centre, keeping them safe and surrounded by the people who love them.

The opening of Scotland's first Bairns Hoose in 2023 signified a long-awaited and desperately needed transformation in protection, care, justice and recovery for children and young people in Scotland who are victims and witnesses of crime.

The Children 1st Bairns Hoose. located in the west of Scotland. is designed to feel like a family home. It's a child-friendly, safe and welcoming place for children to go to once a crime has been reported.

At the Bairns Hoose, each young person can give evidence. receive medical care, take part in decisions about their protection and get support to recover from the trauma they have experienced. There is also a space where their wider family can get support to understand what has happened to their child and how best to help them through it all.

Bairns Hoose is giving children the support they need and help to recover from their experiences.
